2nd APRU-IRIDeS Workshop on Building Disaster Resistant Universities

~Is Your University Ready for the Next Natural Disaster?~

A special workshop focusing on preparedness for natural disasters will be organized at Tohoku University in Japan under the APRU Multi-Hazards (MH) Program. Learn how to develop and maintain an effective university emergency plan that will help your university recover following a natural disaster

Twenty-two APRU member universities responded to a campus safety survey. While many strengths were recognized, there were also areas identified as needing further development. Based on the request through the survey, the MH program organized the workshop on Building Disaster Resistant Universities in 2016.

This workshop aims to share experience of disaster preparedness on campus and identify challenges and issues, discuss how to strengthen their current management plan, and focus on various aspects of disaster management on campus – chemical, pandemic and natural hazards

Recommendation from 1st campus safety workshop

The keys to campus safety are as follows:

- 1) Involving a policy group consisting of the executive leadership of the university to make crucial policy decisions (closing the university etc)
- 2) Developing an emergency management plan (preparedness and response plan etc)
- 3) Conducting exercises, drills or simulations using the existing plan to assess its efficacy
- 4) Reviewing the plan every year or following any emergency event to determine whether it can cope with emergencies and it suits the current university structure

In order to materialize the key elements, universities are required to invest in:

- 1) Commitment from university leadership and inclusion of any legal authorities governing emergency management
- 2) Adequate funding to develop plans, purchase emergency equipment, and hire dedicated staff
- 3) A dedicated emergency operations center staffed with appropriate staff who have been trained
- 4) Training exercises with staff and leadership
- 5) Mutual aid partnership with local entities outside of the university
